CALL TO ORDER

A meeting of the Rowan University/Rutgers—Camden Board of Governors was held on September 28, 2022, at the Joint Health Sciences Center, 201 South Broadway, Camden, New Jersey. Full board and public participation was provided in person and virtually via Zoom. The meeting was called to order at 1:00 p.m. by Chair Mayer.

OPEN PUBLIC MEETINGS ACT STATEMENT Ms. Robinson read the Open Public Meetings Act Statement of Compliance.

ROLL CALL

At the direction of Chair Mayer, Ms. Robinson took attendance by calling the roll.

PLEDGE OF ALLEGIANCE

Chair Mayer asked everyone to rise for the Pledge of Allegiance.

#### **OPEN SESSION**

Chair Mayer stated that in accordance with Resolution 2022-01-03, which was adopted on January 18, 2022, today's meeting was started in Executive Session at 12:30 p.m. Topics discussed in Executive Session were legal, acquisitions, and personnel. These matters were also discussed in open session. At that point, a motion was made, seconded, and approved unanimously to move into open session.

## APPROVAL OF PRIOR MEETING MINUTES

Chair Mayer asked for a motion to approve the minutes from the Board's previous meeting held on July 12, 2022. A motion was made, seconded, and the minutes were approved unanimously.

#### RECUSALS

Chair Mayer asked if there were any recusals to be noted for the record. No recusals were noted.

#### **AGENDA CHANGES**

Chair Mayer asked if there were any agenda changes. Mr. D'Astuto noted the addition of one walk-on resolution: 2022-09-14 (Resolution Appointing Dean D'Astuto as Interim Chief Executive Officer).

#### CEO REPORT

As Ms. Dana Redd resigned from the Joint Board as CEO and accepted the position of CEO and President of Camden Community Partnership, COO Dean D'Astuto reported to the board. His report focused on the board's academic programs and grant funding efforts.

Mr. Corey Hoffman leads the Joint Board's academic program initiatives. In collaboration with program partners (the Center for Family Services and the Camden Coalition of Healthcare Providers), the Joint Board hosted a six-week summer bridge course at the Joint Health Sciences Center for the current cohort of the Certified Medical Assistant Pathways Program. This course helped to prepare the students for full-time enrollment in the CMA training program at Camden County College beginning in September. The cohort of 15 students is on track to graduate as certified medical assistants in spring 2023.

The Alzheimer's Journey Coordinator's Program, another educational initiative of the Joint Board, began its fifth program year. The 10-month certificate program is managed in collaboration with Camden County College and prepares

students to serve as a support system for those experiencing Alzheimer's Disease as well as their families.

The Joint Board is currently working on two grant applications. In conjunction with EwingCole and the legal team from DeCotiis, the Joint Board is working on a capital grant application for funding that will move forward Phase III of the Joint Health Sciences Campus. The application is due 10/28/2022. If awarded, the funds will allow the Board to meet the growing needs of Rutgers University, Rowan University, Cooper Medical School of Rowan University, and Camden County College's Camden Campus.

The Joint Board has also entered into an agreement to partner with several Delaware Valley institutions led by the University City Science Center to apply for a grant that could lead to \$160 million in funding over five years to improve health equity in New Jersey, Pennsylvania, and Delaware.

Ms. Sandy McAndrew has again coordinated "Food Truck Thursday" at the Joint Health Sciences Campus. This initiative is very popular with building occupants, students, and personnel from surrounding institutions.

Finally, Mr. D'Astuto congratulated Ms. Dana Redd on her new position as CEO and President of Camden Community Partnership. He thanked her for her four years of exceptional leadership as CEO of the Joint Board. The Joint Board looks forward to continuing working with Ms. Redd in her new capacity.
